Boating Club Contract and Agreement

- Fuel is additional on each rental. Renter is responsible on each visit to pay for fuel consumption. The amount will be automatically charged to the credit/debit card on file. Prepaid cash payment accepted in \$100 increments.

- There will be no refunds due to inclement weather. _____
- Boating Club Members may reserve boats on Memorial Day for an additional .25 points, Labor Day for an additional .5 points. July 4th rental will be charged full point value. No cancellation permitted on July 4th and Labor Day reservations. _____.
- Availability will be based on a first come basis. The customer is not in any way guaranteed a boat just by showing up. The marina will reserve and guarantee availability by means of standard reservation policy.

- Reservation policy: The renter has until 4 P.M. the day before the rental date to move or cancel with no penalty. Date change dependent on availability. After 4 P.M. deadline the renter will be charged full point value. No exceptions. _____
- All points must be used during the 2026 rental season or they will be forfeited. Platinum, Gold and Silver points carry forward one season. _____
- The original owner of this agreement may allow others to use points with the following terms. The original owner of this agreement is the only person authorized to reserve. The second party must bear all legal obligations and complete all required documents prior to the boat being released. The original owner of this agreement will be held responsible for any liability, damage, loss or unpaid expenses that may occur. The second party must leave a credit card deposit in case of damage. _____
- All safety equipment is included and will be supplied at no charge by the rental facility. It is the responsibility of the renter to return all safety equipment provided or be charged for the loss. _____
- The original owner of this agreement may reserve one or multiple boats, but must have enough _____ points paid in advance if the customer is on the payment plan. _____
- If using an early pick up or drop off option, the renter must have completed a special form and _____ have made verbal arrangements with the marina. _____
- Points may be used at either location but all reservations must be made through the West Branch location. _____
- Boating Club purchases must be made 48 hours prior to the first reservation day. _____
